VITA-PAKT SELECT ORGANIC LEMON PEEL GRANULES (-4+8)

Description

Select Organic Lemon Peel Granules (-4+8) peel are obtained from clean, sound, mature Organic Grown and Certified lemons of the species *Citrus limon*. The fruit is washed and the juice extracted. Lemon peel is prepared from the shaved flavedo portion of the expelled peel which has been cut, dried and sifted to the desired granulation.

Shipping and Storage: Carrier shall be clean, dry and suitable for food transport. Store in a cool, dry warehouse, preferably below 70° F and less than 65% RH in tightly sealed containers. Do not chill below 40° F.

Shelf Life: If stored and handled under recommended storage conditions in original containers, use within 2 years for best quality.

Packaging: Packed in a fiberboard box lined with a polyethylene bag. Net Weight 50 lbs.

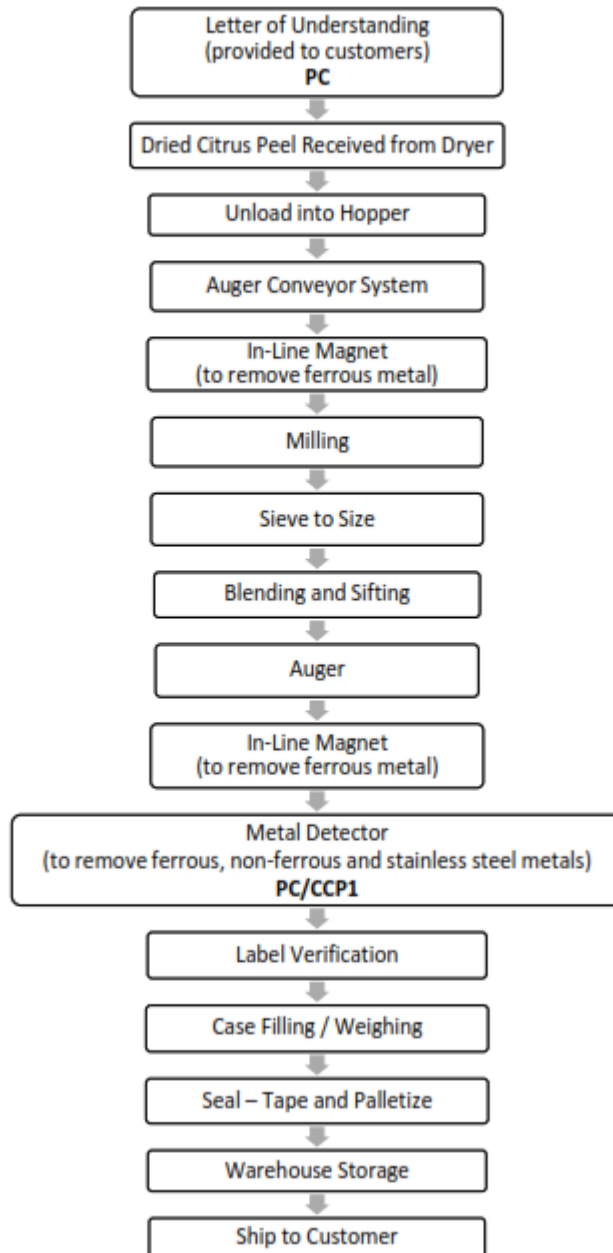
